 - Delays in downsizing Developmental Centers will reduce cost savings which can be used to serve more people on the waiver waiting list.

Dear Senator _____,

I oppose any delay in the Department of Health and Hospital's (DHH) plan in downsizing its Developmental Centers. It has been reported by DHH officials that approximately 200 individuals living in Developmental Centers have the lowest levels of needs. Amendment 232 to HB1 would prohibit DHH from transferring any resident of Pinecrest Developmental Center into a community setting without first creating a Commission to review that resident's status and ability to function in a new setting. There is already a State Office Review Committee that performs this function.

This amendment would prevent progress in converting Louisiana's system supporting people with developmental disabilities. Louisiana's plan to downsize these facilities is reflective of best practice and will allow savings to be realized now and in years to come. These cost savings could provide supports and services to some of the people waiting up to eight years for waiver services. Please do not allow delays to Louisiana downsizing its Developmental Centers.
