The Senate Finance Committee begins debate on House Bill (HB) 1 on Monday, May 30<sup>th</sup>. HB1, the state's budget for next year, passed through the House of Representatives with drastic cuts to DHH's budget that DHH indicates will slash or eliminate home and community based services such as the **Cash Subsidy program** and **Individual and Family Support services** and result in another **7.5 percent rate cut to providers**. **Sample Letter - Personalize how the cuts will impact you and your family**

**Dear Senator**

I am writing to urge you to restore the \$120 million dollars of state funding that was cut from the Department of Health and Hospitals' (DHH) budget. These funds are needed in HB1 to support vital programs that serve people with disabilities necessary for them to live in the community and out of more expensive institutions. DHH has indicated that the cuts made by the House of Representatives will result in reductions or elimination to programs that support families of adults and children with the most severe disabilities, adults with disabilities who have successfully moved out of nursing homes and nearly 5,000 children who rely on specialized health care. The support these individuals and families receive is their lifeline to maintain their independence in the community - at less cost to the state. Please protect Louisiana's most vulnerable citizens and restore ALL of the cuts to DHH's budget.

**Additional Information**

The House of Representatives stripped more than \$120 million dollars of State funds from DHH's budget. Since most of these funds would get federal matching dollars these cuts would total reductions of more than \$300 million dollars to cover vital services.

DHH has indicated these cuts will result in:

- Elimination of the Cash Subsidy Program for children with severe disabilities in many regions of the state.
- Loss of Individual and Family Support Services for over 300 families of individuals with developmental disabilities throughout the state.
- Elimination of contract funding for:
  - the Supported Living Program for individuals with Adult-onset disabilities
  - Children's Hospital Diabetes Clinic
  - Tulane University Hospital-Cystic Fibrosis Clinic
  - LSU Shreveport NICU Follow-up Clinic
  - LSU Earl K. Long Pediatric Clinic.
- Reduction of contract funding to the Families Helping Families Resource Centers
- Services to nearly 5,000 children with special health care needs will be drastically reduced as a result of cuts to Children's Special Health Care Services.

- Elimination of vital community services for 200 people who have successfully transitioned out of psychiatric hospitals.
- Loss of psychiatric medications for non-Medicaid eligible (indigent) persons diagnosed with serious mental illness and/or addictive disorders.
- Elimination of the State Personal Care Assistance Program.
- Cuts to Adult Protective Services for people with disabilities.
- Cuts to Single Point of Entry delaying access to Long Term Personal Care Services and the Elderly Waivers.
- Elimination of plan to expand self direction in DD and elderly waivers statewide.
- 7.5 percent rate reductions to providers of services for people with developmental disabilities
