D.D. Council Quarterly Report October 2011 Louisiana Department of Education (LDE)

1. Striving Readers Comprehensive Literacy (SCRL) Grant

Schoolchildren across Louisiana will soon benefit from a federal grant valued at approximately \$28.5 million and intended to improve the reading and writing skills of students from birth through twelfth grade. In fact, all total, the state is expected to receive an estimated \$142.4 million over a five-year period from the federal SRCL Grant. Although 35 states applied for the funding, Louisiana is among only six states selected to receive this award from the U.S. Department of Education (USDOE).

The SRCL Grant requires states to use at least 15 percent of the grant to serve children from birth through age 5, while 40 percent of the federal funds must go toward supporting students in grades K-5, 20 percent of the federal aid must be allocated to support middle school students, and 20 percent must be designated to support initiatives for high school students. The remaining five percent may be set aside for state administration of the grants. Special education is included within grant activities.

Louisiana's SRCL grant will be used to fund a new program, Literacy is for Everyone (LIFE) Promise, which is modeled after the state's highly successful K-12 Literacy Pilot Program. LIFE Promise will be implemented in two cohorts: the first comprised of 18-21 LEAs, which will begin the program in year one; and a second group of eight to ten LEAs, which will begin the program 18 months later. LEAs will be awarded funds based on the strength of their proposed plans. The application process begins in fall 2011, when the Louisiana Department of Education (LDOE) begins accepting pre-applications. Districts may choose to take advantage of technical assistance, which will be made provided by LDOE staff. Successful LEA applicants will be notified in spring 2012.

5. Data Summits

With support from the Picard Center for Child Development and Lifelong Learning, the LDE conducted five one-day data summits in regions across the state between 8/29/11-9/11/11. School systems were asked to send a district team comprised of the following: district superintendent/designee, special education director/supervisor, accountability coordinator, and one additional district key personnel. Participants received a detailed district-specific special education data profile and companion workbook which served as the focal point of the sessions. The sessions were designed to prepare district leaders to understand and take appropriate action related to data (e.g., determine where to allocate resources, provide intervention). Facilitators guided participants in applying a data-to-action process using their own district's data. The LDE is in the process of planning for next-steps to these summits.

9. Autism

LASARD (Louisiana Autism Spectrum and Related Disabilities) Project

The LDE continues to fund the LASARD (Louisiana Autism Spectrum and Related Disabilities) Project through the LSU-Human Development Center as a means of providing support to Louisiana schools on best educational practices for students with autism and related disorders. LASARD provides this support via a variety of means including technical assistance and training to participating districts (Allen, DeSoto, Lafayette, Lincoln, Natchitoches, Recovery, St. Charles, St. Mary, and St. Tammany), as well as professional development offerings (e.g., face-to-face workshops, on-line modules, on-line workgroups) that are available to interested parties outside of these specific districts. Recent activities include the development of a DVD for the LDE entitled "An Intro to ASD and Educational Programming." Related introductory trainer-of-trainer sessions will be conducted in all 8 educational regions of the state during October and November. Representatives from each district are expected to attend. Acknowledgement of Advanced Professional Development in Autism Spectrum Disorders

In school year 2011-2012, the LDE will field test a process whereby qualified personnel can submit documentation to support an "Acknowledgement of Advanced Professional Development in Autism Spectrum Disorders." The purpose of establishing such a recognition process is to encourage personnel to develop skills related to supporting students with autism, and to recognize these individuals so that their expertise can be tapped into as appropriate.

10. Prevent/Teach/Reinforce 2011-2012

During the 2011-2012 school year, the LDE is rolling out a major Positive Behavior Interventions and Supports (PBIS) tertiary level initiative designed to provide districts a proven, intense new way to deal with the children that are providing the most serious challenges to the learning environments. The new model, being piloted in all eight regions of the state, is known as Prevent-Teach-Reinforce (PTR). Highlights of the initiative are as follows:

- Dr. Don Kincaid, the state's USDOE Liaison through its Office of Special Education (OSEP), and his colleague, Dr. Rose Ivonnone, have been contracted with as the project's primary trainers and will be providing ongoing consultation during the initiative.
- They have conducted a train-the-trainer orientation of the process to an initial group of eight state-recognized experts in tertiary training/issues.
- These "Cohort I" I group of eight trainers will then conduct "train-the-trainer" trainings of school social workers, school psychologists, and other behavior interventionists throughout the state's regions.
- District schools that have demonstrated the most need and readiness for tertiary delivery will be provided the training. PBIS implementation with fidelity (Benchmarks of Quality/internal and SchoolWide Evaluation Tool/external evaluation scores) at the Universal (green) and Secondary (yellow) are

prerequisites for consideration as well as selection being based on the identified districts' excessive suspension and expulsion of students with disabilities.

- Success of the model will be measured by
 - usage of pre/post child outcome measures, including, of course, behavioral change
 - Pre/post technical adequacy of the FBAs (Functional Behavior Assessments)/BIPs (Behavior Intervention Plans) completed by the behavior coaches
 - Fidelity scores of teachers implementing the behavioral interventions
- The model will involve:
 - Two full days of classroom instruction
 - Two full days of actual in the field work of a case being demonstrated to the new behavior coach
 - Two full days of the behavior coach then being shadowed by the coach
 - The completion of a case study by the new behavior coach that must be submitted to the national experts to certify the behavior coach in the process, both as a practitioner and/or future trainer
 - Ongoing consultation of the Cohort I and new behavior coaches by both the Cohort I trainers and the national consultants
- A total of at least 22 districts throughout the state will be trained in this
 process. At the end of the process the regions will have access to 45
 personnel fully trained in the process that can both roll it out in future "trainthe-trainer" trainings and use the process within districts.
