If you support incentivizing integrated employment of people with developmental disabilities contact members of the House Way and Means Committee before Monday, May 13th.

[House Bill 268](#) by Rep. Foil will provide tax incentives to businesses that employ people with developmental disabilities. The House Ways and Means Committee will hear HB 268 Monday.

Rep. Foil will propose an amendment to the bill when it is introduced to define employment as integrated, competitive, individual employment in the community in which the individual is paid at least minimum wage.
