[HB1](#) will soon be considered by the Senate Finance Committee. The bill currently includes funding to fill all vacant waiver slots, create 200 additional NOW slots, and restore funding to other disability services including the Individual and Family Support Program, Families Helping Families, and Louisiana Rehabilitation Services.
