The Office of Aging and Adult Services aims to develop, provide and enhance services that offer meaningful choices for people in need of long-term care. The office is committed to developing a long-term care system that provides choice, ensures quality, meets the needs of consumers and caregivers, and does so in a fiscally responsible manner.

OAAS serves individuals with diagnoses cerebrovascular Accident (stroke), congestive heart failure, Alzheimer's, dementia, Parkinson's, traumatic brain injury, multiple sclerosis, hemiplegia, hip fractures, osteoporosis, cancer, diabetes, emphysema/COPD, and renal failure, etc. OAAS assesses and evaluates eligibility to receive Medicaid services by assessing the individual's ability to perform activities of daily living, their ability in making decisions and effectively communicating with others, behavioral conditions, receipt of rehab therapies or special services and also their clinical conditions.
