A quorum was established and the meeting was called to order at 8:33 a.m. RaShad Bristo made a motion to accept the revised agenda, which included the rescheduled meeting date and time, as well as Roman Numerals for agenda items. The motion was seconded by Randall Brown. In a roll call vote, the motion passed with one objection.

Committee Member, Bambi Polotzola expressed that she does not agree with individually scoring/rating the membership applicants in a public format, as indicated in the membership committee meeting protocols, and suggested doing that part in executive session. Review of Applicants

Dr. Hyacinth McKee (Chair) went over the protocol for the Committee Membership Meeting. Amy Deaville, Executive Director reviewed the demographics of the current council membership and the demographics needed to stay in compliance with the DD Act.

Interviews were conducted with fifteen (15) applicants across the state. Each applicants' name and region was posted. Each committee member (interviewer) then stated their rubric score for each applicant they were assigned to interview in four categories on a scale between 1 and 5 (5 being outstanding and 1 being poor) including:

- 1. Fully supports the values of the DD Act
- 2. Familiar with the Council and understands and supports its purpose
- 3. Has the capacity to be a strong systems change advocate
- 4. Demonstrates leadership qualities

Scores were recorded and tallied for each applicant.
