

[Senator Dan Claitor](#) has worked tirelessly for over three years to get equitable funding to schools for students with disabilities. Three years ago he authored SCR124 to request BESE to fix this inequity and authored SB267 when it became clear the inequity would continue.

[Senator Edwin Murray](#) co-author of SB267.

[Representative John Bel Edwards](#) handled SB267 on the House floor and successfully argued to not delay the inequity for another year.

[Representative Jerome "Dee" Richard](#) amended SB267 to remove the delay that had been added by the House Education Committee.

Representatives [Rogers Pope](#), [Steve Pylant](#), [Patricia "Pat" Smith](#), and [John Schroder](#) each advocated strongly for the House to support funding go to schools serving students with disabilities immediately without another year of delay.

## What happened with the attempt to delay fairness?

The House Education Committee amended SB267 to delay the implementation of an equitable funding formula for one year. Representatives heard the calls of LaTEACH members and overwhelmingly stripped this delay on the House floor with a vote of 69 to 31! In the end the House passed SB267 with a vote of 101 in support and only 3 against! Every Senator voted in favor of SB267!
