Current version of HB1 includes \$1.6 million to fill vacant waiver slots; Restoration of LINCCA funds saving Individual and Family Support, Flexible Family Fund, and State Personal Assistance Services programs and Families Helping Families contracts; restoration of most of the \$235 million in cuts to LDH; and increased SGF for LRS. The budget expected to pass can be considered a best case scenario but still falls short from meeting the needs of individuals with disabilities. The budget does not adequately address the waiver waiting list of over 15,000 individuals; restoration of cuts to the Human Service District/Authorities; restoration of all cuts to EarlySteps; funding for an enhanced waiver rate to serve those with complex behavioral and/or medical needs; funding for overtime pay for DSP or increased rates for waiver providers; and funding to allow LRS to draw down its full federal allotment.
