# Children's Special Health Services (CSHS)

- Provides medical and family support services to children with special health care needs and their families in Louisiana.
- Services provided in CSHS Clinics & in private health care facilities:
  - Health care services
  - Medical tests and procedures
  - Hospitalization

## Bureau of Health Services Financing (BHSF) - Medicaid

- Healthcare services (physician, hospital, pharmacy, etc.) for people who meet income and other requirements
- Healthy LA LA's Medicaid managed care system
- Funding/policy/compliance for long term care services (waivers, Long Term Personal Care, institutions)

#### More on Medicaid

- Most people w/ DD remain in legacy Medicaid
- Early, Periodic, Screening, Diagnosis and Treatment (EPSDT) for children under 21 – all medically necessary services
- Family Opportunity Act children with disabilities up to 300% poverty level

#### LA Rehabilitation Services (LRS)

- Assists persons with disabilities in their desire to obtain or maintain employment and/or achieve independence in their communities by providing rehabilitation services and working cooperatively with business and other community resources.
  - Vocational Rehabilitation
  - Independent Living Program
  - Louisiana Rehabilitation Council

#### Vocational Rehabilitation Services

- Vocational guidance, career counseling and job placement
- Transition from School to Work
- Independent Living
- Transportation to access vocational services
- Vocational and other training services
- Rehabilitation technology, including assistive technology
- Occupational tools and equipment

- Mandated



#### Department of Education (LDE)

- Board of Elementary and Secondary Education (BESE)
  - Enacts policies and adopts regulations governing all schools
  - Operates the state's 2 special schools and Special School Districts
  - Authorizes Type 2 & 5 Charter Schools
  - Fiscal agent responsible for distribution of State and Federal funds
  - Appoints the Supt. of Education

  - Provides information, technical assistance and oversight/monitoring of education programs provided by Local Education Agencies

- Serves as a focal point for senior citizens and administers a broad range of home and community based services through a network of 36 Area Agencies on Aging.
- Serves as an advocate for the state's elderly citizens

### Office for Citizens with Developmental Disabilities (OCDD)

- Single point of entry into DD system
- Oversees public and private residential and community supports and services for people with developmental disabilities
- Community services are administered through 10 Regional Human Services Districts/Authorities called Local Governing Entities (LGEs)
