

Council's 2018 Legislative Advocacy Agenda

December 4, 2017

The Louisiana Developmental Disabilities Council adopted its 2018 Legislative Advocacy Agenda with input from its grassroots advocacy network (LaCAN) and the Families Helping Families Centers. Four issues are included on the agenda in the areas of home and community-based services and education.

Home and Community-Based Services

As it has done for many years, the Council will continue to advocate for the increased availability of home and community-based supports and services so people with developmental disabilities can remain in their own homes and be fully participating members of their communities. The Council is calling for increased access to waiver services, an enhanced waiver rate to support people with complex behavioral and/or medical needs, and implementation of the TEFRA Medicaid State Plan Option. The Council did not include increased funding for the Human Services Districts/Authorities in its statewide legislative advocacy agenda, but will assist advocates in the Northwest LA and Florida Parishes regions in advocating for additional funding with their regional legislative delegations. The districts/authorities in these two regions are the lowest state funded per capita in the state.

Education

Behavior is and always has been a major concern of both parents and educators, particularly those of students with disabilities. As a result, the Council will advocate for the Louisiana Department of Education to develop a proactive, data-driven plan of action to ensure schools and parents have access to resources and evidence-based approaches to behavior.
