Forty-one (41) consumers received services through the SPAS program this quarter.



Race (Figure 1):


Quarterly: African American (21) Caucasian (21)

Disability: Consumers represent a wide range of diversity in terms of disability, including acquired brain injury, Quadraplegia, spinal cord injury, stroke, visual impairment, muscular dystrophy, severe lung disease, acute renal failure, multiple sclerosis, chronic kidney disease, sickle cell anemia, brain aneurysm, partial paralysis, and individuals with multiple disabilities.



Expenditure of Funds (Table 4, Figure 4)

Funding for direct services through the State Personal Assistance Program for July 1, 2017- June 30, 2018 is \$753,281.00. Total spent is \$727,666.63 leaving \$23,614.35.




