<b>MHSD</b>	These funds were used to assist families with utility bills, rental assistance, transportation and home settlement items.
<b>CAHSD</b>	No funds were expended; in a letter to CAHSD dated 8/5/19, the LaDDC expressed concerns about the historical use of funds for the contracted behavioral health consumer-run drop in center's rent, utilities, phone, cable, internet, gas for client transportation, food for client lunches, peer staff, peer-led educational workshops, and related supplies. Mental health block grant funding is currently being utilized for the contract.
<b>SCLHSA</b>	SCLHSA prepared 41 check writes for requests in the 2nd Quarter, \$16,620 for adults that included assistance with utility bills, home furnishings (bed frames & mattresses, washer & dryer), driving school registration, rent, and home repair due to termite damage. Additionally, SCLHSA paid four (4) peer support specialists for their services in the Behavioral Health Clinics, \$12,788.08 during this quarter. Total Year to Date Expenses directly paid for adult needs through December 27th is \$132,233 -- \$82,233 is covered with Mental Health Block Grant Funds. The additional services provided to meet direct adult needs include transportation for clinic appointments and personal care attendant services that are not covered by any insurance plan.
<b>CLHSD</b>	1/6/2020 December reports not in yet, will report as soon as I receive them.
<b>NLHSD</b>	These funds are used to provide support services to residents of the McAdoo housing program (permanent housing). They enter the program through referral from the Centralized Access Point, HOPE Connections and based on the assessment score from the VI-SPDAT. A wait list is not kept by NLHSD.
