- Position posted on ALL sites developed by the committee during the last meeting
- LANO will use a score sheet/rubric similar to the one the committee will use to narrow applicants to the 12 most qualified.
- LANO will request the top 12 applicants submit a video between January 8-13, 2021
- LANO will submit the top 12 vetted applicants to the search committee along with
 - o LANO Score Sheets
 - Videos
 - Resumes
- Search Committee will select top 6 candidates by January 28, 2021
 - Score sheet/rubric will be used to score resume and video
