Still Time to Share the Importance of Disability Funding with the House Appropriations Committee!

April 16, 2021



Wednesday, April 21st House Appropriations meets at 9:30 AM to hear public testimony on the budget. ([Agenda](#))

House Appropriations will be holding public testimony on the budget ([HB1](#)) April 21st. The committee needs to hear from you about why funding home- and community-based services and resources for individuals with developmental disabilities is important.

Currently, the main budget bill *does not* include the following items:

1. [Additional funding for the Families Helping Families \(FHF\) Regional Resource Centers](#)
2. [Funding to increase home and community-based service rates for those services provided by Direct Support Workers \(DSW\) and a minimum starting pay requirement of at least \\$8.65 per hour for DSWs](#)

If these issues are important to you or someone you know, there is still time to take action!

How to Take Action

Share your personal story and explain how the issues above would affect you, your family or someone you know.

1. **Email or call** the Chair and members of the House Appropriations Committee before the meeting on Wednesday, April 21st. Find your member of the House Appropriations Committee at the end of this alert.
2. **Email** h-app@legis.la.gov your public comments about the budget no later than Tuesday, April 20th, by 11:59 AM for your comments to be included in the meeting record.
