#### **Recap of the 2021 Legislative Session**

The 2021 Legislative Session officially closed on June 10th, 2021. For this year's session, GODA created a spreadsheet to track disability-related legislation. It is still being updated weekly as bills are signed into law (or vetoed). You can find the spreadsheet [here](#). Below you will find updates on legislative instruments that were particularly relevant to the disability community.

HB446 by Representative Butler: Creates and provides for the office of the state Americans with Disabilities Act coordinator within the division of administration. *Now Act 452. Effective 8/1/21.*

HB172 by Representative Butler: Provides Medicaid coverage for dental care for adults with developmental disabilities. Passed the legislature and signed by the Governor. *Now Act 450. Effective 8/1/21.*

HB253 by Representative McKnight: Provides relative to the governance and funding of the Special School District, which provides special education services through its schools and programs. Passed the legislature and signed by Governor. *Now Act 468. Effective 7/1/21.*

HB594 by Representative Miller: Prohibits insurance companies from placing a cap on the amount they will pay for noninvasive ventilator treatments. Passed the legislature and signed by the Governor. *Now Act 379. Effective 8/1/21.*

SB86 by Senator Foil: Requires the governing authority of each public school to develop and adopt policies for the installation and operation of video cameras in certain classrooms. Passed the legislature and signed by the Governor. *Now Act 456. Effective 6/23/21.*

#### **Annual GODA Conference will be Virtual: Register Now!**
