LRS Director's Quarterly Report
June 2021**

PROGRAM SERVICES

Pre-Employment Transition Services:

Louisiana Rehabilitation Services (LRS) provides Pre-Employment Transition Services (Pre-ETS) to students with disabilities between the ages of 16 and 21 with an active Individualized Education Plan (IEP) or who meets the definition of a student with a disability as covered under Section 504. Pre-ETS include Job Exploration Counseling, Work-Based Learning Experiences, Counseling on Post-Secondary Opportunities, Workplace Readiness Training and Training on Self Advocacy. LRS is currently serving approximately 2,231 students statewide. That includes providing Pre-ETS in 53 of the 64 parishes and over 340 schools in the state.

Also, LRS currently has 13 active Third Party Cooperative Agreements (TPCA) with local or state education providers to provide Pre-ETS and is continuing to pursue additional TPCA's with local and state education providers.
