

Executive Director's Report January 2022 Council Meeting

AoD

The Administration on Disabilities offered an opportunity for Grantee Networks (these include DD Councils) to participate in *Walking the Walk: Prioritizing Diversity, Equity, and Inclusion in Organizational Culture and Programming to Support People of Color with Disabilities*. This peer e-learning opportunity is 10 sessions long from September through December.

OCDD Covid-19 Waiver Exceptions Focus Groups

DD Council staff participated in Focus Groups facilitated by OCDD to discuss the need for continuing some of the Covid-19 waiver exceptions currently in place. The focus groups centered around three topics: Legally Responsible Adult as Paid Caregiver, 16 Hour Rule and Virtual Services. These meetings gave stakeholders the opportunity to express what works with the current exceptions, what doesn't and how OCDD can continue the service availability post the public health emergency. OCDD is including these services in waiver amendment which should be submitted to CMS in early 2022.

HCR 45 Workgroup

House Concurrent Resolution 45 was passed in the 2021 Regular Legislative Session. In summary, the resolution asked the Louisiana Department of Health (LDH) to conduct a study concerning the feasibility and desirability of implementing a system for tracking the location of children with intellectual and developmental disabilities. The work has been completed and a report compiled. The report will be submitted in January 2022.

Discussed LA legislation and the legislation advocates are attempting to pass in Maryland. Conversation centered around barriers and approaches in LA used to pass the legislation and lessons learned.

November 10 – Post COVID-19 Waiver Exceptions General Stakeholder Forum

Attended the Office for Citizens with Developmental Disabilities (OCDD) stakeholder forum to learn more about the department's plans to continue certain Appendix K Exceptions: family as paid caregivers, DSP 16 hour rule, and virtual visits/services options. The department hosted a

series of individual forums with stakeholders including parents, individuals with disabilities, provider agencies, advocacy group members and other stakeholder groups to develop new waiver amendments and rules for the four OCDD Medicaid waivers. November 10 – OCDD State Advisory Committee (SAC)

Attended the Office for Citizens with Developmental Disabilities (OCDD) State Advisory Committee meeting on November 10, 2021. Multiple updates were shared from the Regional Advisory Committees and the department. Updates included, but were not limited to,

We discussed the proposal that was submitted to the Governor's office with a request to include this initiative in his 2022 legislative package. Also discussed the Council's and LaCAN's advocacy related to this issue and how the Alliance could support those efforts.

Purpose of the meeting was to discuss in more detail JPHSA processes and explain the Council's role in monitoring the Consumer Care Resources and Flexible Family Fund programs.
