Statewide Independent Living Council (SILC)

As of January 1, 2022, the Statewide Independent Living Council has transitioned out of the Governor's Office of Disability Affairs to become an autonomous, non-governmental entity. This is to meet their federal obligations. Jamar Lanier Ennis has assumed the role of Executive Director.

Governor's Advisory Council on Disability Affairs (GACDA)

The Governor's Advisory Council on Disability Affairs held their quarterly meetings December 13-15, 2021. The committee meetings took place via Zoom and the full council meeting was held in a hybrid format.

During the Education Committee meeting, it was determined that GACDA would follow up with Superintendent Brumley regarding the issues they highlighted in their 2020 letter. It was also decided that a needs assessment would be created and sent to GACDA Committee members, so they can determine what should be addressed first.

Voting Accessibility

GODA Senior Coordinator, Lillian DeJean, was appointed to the Voting Systems Commission (VSC) by Governor Edwards to represent the disability community. The next VSC meetings will take place on January 19th and February 2nd. Additionally, the Governor's Office of Disability Affairs met with the Secretary of State's (SoS) Office in December to discuss the following items:

- <u>Remote Ballot Return:</u> GODA discussed the possibility of implementing a remote ballot return system with SoS, so the disability community can have access to a completely accessibility absentee voting experience.
- <u>Commissioner Training:</u> GODA discussed possible ways to improve poll worker and commissioner training as it pertains to disability etiquette and accessibility barriers/solutions.
- Accessibility Presentations for the VSC: GODA and SoS discussed possible
 presentations on accessible voting for the January Voting Systems
 Commission meeting, so the commission members and public can have a
 broader understanding of some of the barriers the disability community face
 when voting.

Staff Changes
