

Action Alert #13 Senate Finance to Vote on FY23 Budget

May 13, 2022



Senate Finance - Sunday, May 15th

After hearing public testimony earlier this month, Senate Finance is ready to vote on the proposed Fiscal Year 2023 budget (<u>HB1</u>), set to begin July 1st. They will meet this Sunday, May 15th, at 1 PM in Room A-B of the State Capitol. Click here for the agenda.

What's Included in the Budget

<u>Additional Funding for Families Helping Families</u> Centers

- Last year, the legislature appropriated an additional \$500,000 in state general fund to the DD Council's budget for the sole purpose of doubling the funding for the nine FHF Centers the Council contracts with.
- Fortunately, this additional funding was amended into the proposed FY23 budget by House Appropriations.

<u>Funding for Comprehensive Dental Coverage</u> for Adults with I/DD

- Act 450 of 2021 by Representative Butler ensures Medicaid coverage for comprehensive dental care be provided to all adults enrolled in any Medicaid waiver program for persons with I/DD.
- \$5.3 million in state general fund is currently included in the proposed FY23 budget to

What's Not Included in the Budget

<u>Funding for Cameras in Special Education</u> Classrooms

- Governing authorities of public and charter schools are required to adopt policies relative to the installation and operation of cameras in selfcontained special education classrooms upon request (Act 456 of 2021).
- Unfortunately, many school districts have cited a "lack of funding" for their failure to develop and implement any such policy despite the law requiring them to do so.
- In House Appropriations, Chairman Zeringue stated the committee did not include the \$8 million needed to fund the installation of cameras in special education classrooms in its amendments because the committee felt the Louisiana Department of Education (LDOE) should be able to identify the funding needed in its current budget. However, no language was added to the budget to instruct LDOE to identify necessary funds.

- During this same committee meeting, an amendment was passed that would appropriate \$8 million to fund cameras in special education classrooms should the Louisiana Department of Health return funds to the state treasury as a result of increased federal funds from the Enhanced FMAP. Unfortunately, this is not a guaranteed source of funding.
