Applications are currently being accepted for an Advocacy Team Leader to lead the LA Developmental Disabilities Council's grassroots advocacy network (LaCAN) in the Greater Baton Rouge and Northshore/Florida Parishes areas:

Region 2 Advocacy Team Leader (Greater Baton Rouge Area)

- Part-time, flexible schedule (approximately 25 hours/week on average)
- Starting Pay: up to \$1,250/month
- Serving Ascension, East Baton Rouge, East Feliciana, Iberville, Point Coupee, West Baton Rouge, and West Feliciana parishes
- Based out of Families Helping Families of Greater Baton Rouge

Region 9 Advocacy Team Leader (Northshore/Florida Parishes Area)

- Part-time, flexible schedule (approximately 25 hours/week on average)
- Starting Pay: up to \$1,250/month
- Serving Livingston, St. Tammany, St. Helena, Tangipahoa and Washington parishes
- Based out of Northshore Families Helping Families

Leader Responsibilities

- Maintain personal knowledge-base on home and community-based services, employment, and education issues related to individuals with intellectual and developmental disabilities.
- Recruit and develop relationships with advocacy members from within their region to keep them informed, encouraged, and engaged in advocacy.
- Develop relationships with local legislators and other key policymakers to educate them about the impact of policy decisions on individuals with developmental disabilities.
- Assist members in developing personal relationships with their policymakers and support them in sharing their story as it relates to advocacy issues.

Who Should Apply

Applicants should be an individual with an intellectual or developmental disability or a parent/family member of someone with an intellectual or developmental disability. Applicants should also reside in the region for which they are applying (see parishes listed above).

Applicants should also have:

- effective verbal and written communication skills
- strong organizational and presentation skills
- proficiency in Microsoft Word and Excel

- basic knowledge of the developmental disabilities service delivery system and educational supports and services for children with disabilities
- reliable transportation (travel required for meetings)
- an unwavering belief that ALL people with disabilities, regardless of the severity of the disability, can and should live in their own home in the community with appropriate supports and be included in school, work and all other facets of community life
- an unwavering belief that people with disabilities should not be segregated

Preference will be given to applicants who:

- have been an active member of the Council's grassroots advocacy network (LaCAN)
- experience working/advocating with the legislature
