## Governor's Advisory Council on Disability Affairs 2023 Legislative Items

GACDA has released its legislative recommendations for the 2023 Louisiana Legislative Regular Session, which will convene on Monday, April 10th. With this year's session being an odd-numbered year, the 2023 Louisiana Legislative Regular Session is generally limited to fiscal matters- although each legislator may file up to five non-fiscal bills.

The Governor's Office of Disability Affairs created a spreadsheet at <a href="https://bit.ly/23GODAlegis">https://bit.ly/23GODAlegis</a> to track disability-related legislation. The link is updated multiple times a day. At the last quarterly meetings, the Governor's Advisory Council took position (support/oppose) on approximately 25 legislative instruments. You can find this information, along with the positions of other disability-focused organizations, in Column F of the spreadsheet.

### HCR14 of 2022 Disability Voting Task Force Legislative Items

Representative Willard authored <u>HB449</u> which provides relative to the rights of voters with disabilities and Representative Glover authored <u>HB553</u> which provides for appointment of a voter with disabilities to the State Board of Election Supervisors.

#### Special School District

The Special School District named Dr. David Martin as the New Superintendent. Before serving as the superintendent at the Tennessee School for the Blind for six years, Dr. Martin worked in the Department of Defense School System for seven years as an elementary school principal and in various other administrative roles since starting his administrator career in 2010. Dr. Martin stated that relationships are essential to him, so he believes in leading through and building relationships with the communities he serves. His goal is to create a solid network of support for the school district and the students being operated, with the broader special education and disability advocacy groups. It is important to him that every decision made is student-centered. In February of this year, Dr. Martin met with members from the Louisiana Commission Deaf (LCD) and Louisiana Association of the Deaf (LAD). He will also speak with some National Federation of the Blind (NFB) members during their state conference on April 15, 2023.
