GACDA Legislative Committee – June 21, 2023

Attended the Governor’s Advisory Council on Disability Affairs (GACDA) Legislative Committee meeting on June 21, 2023. Committee reviewed legislative outcomes of the 2023 Regular Legislative Session particularly those issues followed by GACDA. It was shared that approximately \$100 million in additional funding being requested by Louisiana Department of Health was removed during the last minutes of session. It was also mentioned there has been discussions that the Governor will likely line item veto the \$100 million reduction. There was language included in the budget that would, in theory, protect disability services, but there were concerns that disability services may be broadly defined and inconsistent depending on the group. An Ad-hoc was created to help come up with a standard definition of disability services to share with the department and other groups.
