Of the 13 participants who started the program in January 2023, 12 completed the final three sessions and were eligible to graduate in June 2023.

Three sessions of the 2023 Partners in Policymaking class took place this quarter:

- The fourth PIP session of the 2023 class took place in April 2023. The speakers were Brandi Kelly (OCDD), Debra Weinberg (DRLA), Dr. Francis Hwang (ABA), Cindy Arceneaux and Rose Gilbert.
- The fifth PIP session of the 2023 class took place in May 2023. The speakers were Dr. Gerlinde Beckers (Lions Connected) and Al Condeluci.
- The sixth PIP session of the 2023 class took place in June 2023. The speakers were Meghan Reno (LATAN), Nicole Learson (Parliamentarian), and Courtney Ryland (LRS). The sixth session ended with the class graduation. The graduation speakers were Rebecca Fruge (PIP Coordinator), Amy Deaville (LaDDC), four (4) class graduates and Wilbert Johnson (PIP Graduate Class of 2019).

All three months' sessions and the graduation were held in person at the Baton Rouge Marriott.

There have been over 28,684 units of information and referral completed and 360 trainings conducted with 7,237 individuals in attendance. Centers have also conducted 334 outreach activities to hospitals, pediatricians, school districts, Applied Behavior Analysis (ABA) clinics and physical therapy clinics.</p> <p>The legislature allocated an additional \$500,000 in state general funds to the Council’s FY24 budget ensuring an increase in funding for the Families Helping Families Centers that contract with the Council. At the time this report was compiled, the budget was awaiting final approval from the governor.</p> <p><b>Previous Quarter(s):</b> In October, the Council added to its 2023 Legislative Advocacy Agenda funding for the Families Helping Families Centers currently contracting with the Council. The Council encouraged all stakeholders interested in serving on the board to apply and shared an LaDDC Newsletter on <a href="#">June 23<sup>rd</sup></a>.</p> <p><b>Previous Quarter(s):</b></p> <p>OCDD hosted statewide Roadshows in February and March to discuss the ending of the COVID-19 Public Health Emergency (PHE). The federal PHE will end on May 11<sup>th</sup> which means the Appendix K exceptions are scheduled to end in November. FFY 2023 Cost: \$30,000</b></p>	<p>As LAYLF approaches, outreach has shifted from recruitment to communication with confirmed staff, speakers, and delegates.</p> <p>LAYLF Coordinator continued monthly meetings to discuss LAYLF budget. LAYLF acquired a re-occurring grant from Enbridge for transportation and meals. This grant money will be received yearly, for five years. LAYLF Coordinator obtained preapproval from FHFOA ED and financial manager for all expenses.</p> <p>The Coordinator also collaborated with other FHFOA employees with disabilities to choose the final slate of staff and delegates. Preference was given to persons of color (POCs) and those of diverse backgrounds. A pre-YLF staff training was held mid-June, via Zoom, to ensure that on-site staff training was maximized.</p> <p>The LAYLF schedule has been finalized and all speakers/participants are confirmed (with the exception of legislators for Capitol Day.) Emergency plans have been developed. Manuals and picture schedules are in the creation process. The keynote speaker was Russel Lehmann, who is a self-advocate. He has years of experience in training in advocacy and self-determination for self-advocates, family members, providers, employers, and the general public. In June there were 80 participants registered for the training, 46 participants attended, 19 self-advocates, 22 professionals, and 6 family members. Flyers were sent out to all local chapters of People First, social media, FHF Centers, and our provider email distribution list.</p> <p><b>Previous Quarter(s):</b> People First held a two-day training on October 6<sup>th</sup> and 7<sup>th</sup>. This training provided participants knowledge of the voting and the legislative process. On October 7<sup>th</sup>, participants met at the Capitol with Representative Edmonds, Representative Davis, and Senator Foil. The legislators explained the legislative process and the participants took a tour of the capitol including visiting a committee room and the chambers. At the time this report was created, the budget has not been approved by the governor. Unfortunately, \$100 million dollars of additional funding requested by the Department of Health (LDH) for FY24 was removed from the budget during the final moments of session. LDH appeared before Senate Health and Welfare to discuss reductions that would occur should this funding not be restored. Services to be impacted include behavioral health and pediatric day health centers. There is wording in the budget stating "there shall be no reduction</p>

[Act 84 \(HB367\)](#) aims to streamline the transition of children aging out of EarlySteps by

- Requiring EarlySteps to submit a list of children reaching the age of two and a half each month to the local education agency (LEA) where the child resides;
- Instructing the LEA to coordinate scheduling of any appraisal conferences and the facilitation of services for the child(ren); and
- Requiring LEAs to conduct appraisals year-round to ensure no delays in services occur especially during summer months when schools are typically on break.

[Act 187 \(SB39\)](#) established the Community Options Waiver Fund to provide additional revenues for Medicaid services provided under the Community Choices Waiver, the Adult Day Health Care Waiver or any other Medicaid home- and community-based services for people with adult-onset disabilities.

[HB480](#) of the 2023 Legislative Session by Representative Miller would have allowed people ages sixteen and over as Direct Support Professionals for Medicaid waivers and services. Although the Council remained neutral on this issue and the bill failed to complete the legislative process, the Louisiana Department of Health has agreed to allow this change and will address this through rule changes rather than legislation.

On June 27<sup>th</sup>, OCDD said that due to the uncertainty with the LDH Budget, they had to push back the effective date of incontinence supplies being covered in the waiver to October 1, 2023.

### **Previous Quarter(s):**

In October, the Council added to its 2023 Legislative Advocacy Agenda advocacy focused on providing incontinence supplies to adults on Medicaid waivers. The Council will partner with the Arc of Louisiana to advocate for this issue. Medicaid and the Office for Citizens with Developmental Disabilities or OCDD have started working to add incontinence supplies as a Medicaid covered benefit under the New Opportunities, Residential Options and Supports Waivers. The department shared with the Council a [commitment letter](#) detailing its plans. In April, states will start reviewing eligibility of Medicaid recipients and remove those who are no longer eligible. It is important that all Medicaid recipients ensure their mailing address, cell phone numbers and email are current.
