RE: April 2024 Developmental Disabilities Council Meeting

Act 393 of the 2023 Regular Session amended Open Meetings Law to allow for remote operations (i.e. by electronic means or virtually) of public bodies that meet specific requirements detailed in the bill. The Act also requires each individual agency to promulgate its own rules for remote meetings. The Louisiana Department of Health (LDH) has submitted the documents for publication as a Final Rule in the **March 20, 2024** *Louisiana Register*.

Therefore, we anticipate the Council being able to meet virtually for the April meeting, with an anchor location for those who would like to attend in person. Council members wishing to attend virtually will be counted towards the quorum and allowed to vote on all decisions. Once the rule is published in the *Louisiana Register*, we will send more information about the rules for virtual participation including how public comment will be taken during the meeting as soon as possible.
