## 2024 Special Education Parent Involvement Survey

Each year the Department surveys parents of children with disabilities who receive special education services. The purpose of the survey is to seek feedback on how well schools help to involve parents in the education of their children. We use this information to guide our efforts to improve services and results for children with disabilities and enhance family involvement. Participating LEAs will receive the needed random IDs the week of April 1, 2024. The random IDs are needed for participating parents to remain anonymous. The 2024 Special Education Parent Involvement Survey will open the week after the LEAs receive the IDs.

The Department uses a sampling method to collect this information. Each year, we select school systems to participate in the survey (list below). Parents in the selected school systems should receive information to participate in the survey from their child's school. The survey will be available until July 31.

## Kindergarten Dyslexia Screener

Act 266 (2023) required the Department to select and provide to each public school (at no cost) a dyslexia screener with the following requirements:

- area under curve of 0.80 or above
- developed solely for dyslexia
- evidence-based with proven, published psychometric validity
- not a progress monitoring tool
- used for the sole purpose of determining if a student is at risk

Implementation was subject to the provision of funds, and the legislature did provide funding. The dyslexia screener is to be administered by the teacher in the second half of kindergarten or any time requested by a teacher, parent or guardian. Within 30 days of an at risk result, the parent is to be notified. The first administration of the required kindergarten dyslexia screener is underway.

## **Special Education Leader Collaborative**

The Department is hosting quarterly in-person collaboratives and professional development sessions with special education leaders across the state. The special education team uses feedback from the field, feedback from stakeholders and needs ascertained from data to drive the focus areas and topics for the collaboratives.

## **Local Special Education Advisory Council (SEAC) Report Collection**

The Department will launch a collection survey for local school systems to submit a link to their annual 2023-2024 SEAC report to the Department. This collection will continue through May per legislation and a report will be provided to SEAP in June and posted on the Department's website.
