**Pre-Employment Transition Services**

Louisiana Rehabilitation Services (LRS) provides Pre-Employment Transition Services (Pre-ETS) to students with disabilities between the ages of 16 and 21 with an active Individualized Education Plan (IEP) or who meets the definition of a student with a disability as covered under Section 504 or who is a student who has a documented disability. Pre-ETS include Job Exploration Counseling, Work-Based Learning Experiences, Counseling on Post-Secondary Opportunities, Workplace Readiness Training and Training on Self Advocacy. LRS is currently providing services to approximately **4,382** students statewide.

LRS currently has 16 active Third Party Cooperative Arrangements (TPCA) with local or state education providers to provide Pre-ETS and is continuing to pursue additional TPCA’s with local and state education providers.

## ADMINISTRATIVE SERVICES

### **Louisiana Rehabilitation Council (LRC):**

The next LRC quarterly meeting is scheduled for April 25, 2024, and will be conducted in Lafayette, LA. Information for this meeting is posted on the websites of Boards and Commissions and LWC.

### **Benefits Planning:**

Forty (40) LRS consumers have been directly assisted with their SSI and SSDI benefits planning since October 1, 2023, by the LRS in-house Community Partner Work Incentives Counselor. Lighthouse for the Blind and LSU Human Development Center also continue to provide Work Incentives Planning and Assistance.

### **DIF (Disability Innovation Fund) Projects:**

LRS is continuing to ask for participants for Project STEMM-Up in the New Orleans, Baton Rouge, and Lafayette Regions. Project STEMM-Up activities are funded through a contract with Michigan Rehabilitation Services (MRS). MRS conducted an on-site audit of LRS and Southern University of Baton Rouge (SUBR) on January 23 - 24, 2024, and recently issued a draft report. Rehabilitation Services Administration (RSA) is scheduled to provide on-site technical assistance April 18 - 19, 2024.

LRS staff has met with the Louisiana Department of Education (DOE) to discuss collaboration efforts on the recently awarded DIF grant to target transition resources and referrals in North LA. Also in an effort to increase collaboration efforts, LRS and DOE staff are planning to attend a National Technical Assistance Center on Transition Capacity Building Institute in May, which is intended to lead to a strategic plan for both entities moving forward.

### **Statewide Trainings:**

LRS conducted a statewide vendor training via Zoom on Thursday, March 21, 2024, to update Employment Services vendors on recent changes to the Technical Assistance and Guidance Manual and Fee Schedule. This training focused on the new services, changes to existing services, required forms, and rates.

Throughout the month of March, all Rehabilitation Counselor Associates statewide participated in training conducted by LRS State Office on how to appropriately manage Pre-Employment Transition Services caseloads in an effort to alleviate Counselor responsibilities and conduct more outreach for potentially eligible students.

### **2024 WIOA State Plan:**

The LWC website hosts a page dedicated to the 2024 - 2027 WIOA Combined State Plan, which includes the Vocational Rehabilitation Program. Public comment on this document will be accepted through the LWC website until 11:59 PM on April 26, 2024.
