#### 2024 Special Education Parent Involvement Survey

Each year the Department surveys parents of children with disabilities who receive special education services. The purpose of the survey is to seek feedback on how well schools help to involve parents in the education of their children. We use this information to guide our efforts to improve services and results for children with disabilities and enhance family involvement. Participating LEAs will receive the needed random IDs the week of April 1, 2024. The random IDs are needed for participating parents to remain anonymous. The 2024 Special Education Parent Involvement Survey will open the week after the LEAs receive the IDs.

The Department uses a sampling method to collect this information. Each year, we select school systems to participate in the survey (list below). Parents in the selected school systems should receive information to participate in the survey from their child's school. **The survey will be available until July 31**.

## **Pupil Appraisal Summer Institute**

In an effort to facilitate collaboration and ongoing professional development, the Division of Diverse Learners is planning a Pupil Appraisal Summer Institute (PASI-24.) This one-day conference is scheduled for August 22, 2024 at the Claiborne Building (LDOE) in Baton Rouge, Louisiana. School systems are encouraged to send two attendees. Conference topics will include Indicator 11-Using Data to Make Impactful Changes, Dispute Resolution and Evaluation Processes, Assessment and English Learners, Bulletin 1508 and Related Services Updates/Recommendations, Understanding School Counseling vs. School Psychological Services, and more.

## **Special Education Fellow Cohort 4 Recognition and Launch of Cohort 5**

Sped Fellows Cohort 4 will be recognized during the August BESE meeting. Twenty-two leaders completed the latest cohort.

Cohort 5 is set to launch in the fall. Applications for Cohort 5 are being accepted now through July 31.

## Foundational Literacy Modules for Grades 4-8 Extended Statewide

The Department has extended access to the grades 4-8 literacy modules. The free access includes 5 professional development modules:

- Module 1: Understanding the Science of Reading
- Module 2: Exploring Phonics and Advanced Word Study
- Module 3: Creating Fluent Readers
- Module 4: Developing Vocabulary
- Module 5: Increasing Reading Comprehension

## **Act 266 Kindergarten Dyslexia Screening Update**

Act 266 of the 2023 Regular Legislative Session required that all kindergarten students be screened for dyslexia. The Shaywitz DyslexiaScreen was provided to all school systems using the legislative funding dedicated for this activity, training was provided last spring and kindergarteners were screened prior to the end of the school year. Parents are required to be notified of an "at-risk" screening result within 30 days. Continued support for the dyslexia screening will occur throughout next school year.

#### **Dyslexia Practitioner Cohort 2**

In partnership with the Dyslexia Resource Center, the Department launched Cohort 2 of the Dyslexia Practitioner program. Cohort 2 will include 25 educators. The training includes 140 hours of coursework and 60 practicum hours.

#### **Inaugural Dyslexia Summit by the Center for Literacy and Learning**

The Center for Literacy & Learning, Academic Language Therapy Association (ALTA) Louisiana and Decoding Dyslexia Louisiana is hosting the first Louisiana Dyslexia Summit October 4-5 in Baton Rouge. Dyslexia practitioners/therapists, educators, literacy interventionists, school counselors, 504 chairpersons, special educators, higher education professors, pre-service educators, educational diagnosticians, speech language pathologists, literacy coaches, parents and medical professionals are invited to attend. Registration is open and the cost is \$299. Session topics will include multi-sensory math, dyslexia therapy/intervention, dyslexia 101, science of reading and dyslexia, diagnosis and screening, evaluation, and more.

## **Regional Collaboratives**

LDOE will host <u>regional collaborations</u> with system leaders during 2024-2025. The purpose of these sessions is to facilitate collaboration between LDOE and system level leaders to provide support around continuous improvement and engage in reflection and planning that result in increased academic outcomes.

System leaders will <u>register</u> for the appropriate learning pathway based on their professional role. Special education directors will register for the Instructional Coherence Pathway.
