Hurricane Francine

In response to Hurricane Francine, the Governor's Office of Disability Affairs participated in the coordination of three Emergency Management Disability and Aging Coalition (EMDAC) virtual conference calls to connect state agencies, governmental entities, non-profit organizations serving individuals with disabilities, and disability advocates to provide important updates

Before and after landfall, The Governor's Office of Disability Affairs released multiple Hurricane Francine centric updates via constant contact to constituents, legislators, community based organizations, and other interested parties. These updates included: how to access hurricane state/federal resources, state and local advisories, shelter information, mandatory evacuations, latest federal and state declarations, and information to access press conferences and other important announcements real time.

2025 GODA Local Advisory Council Initiative

GODA will invite statewide elected officials to connect, network, empower, and share best practices how they resolve disability related matters within their local communities. This conference will feature breakout sessions, and presentations from subject matter experts from multiple topics including but not limited to: emergency preparedness, transportation, accessibility, disability inclusion, disability awareness and much more.

Local leaders who desire to establish a disability focused body within their own jurisdiction will have an opportunity to connect with Mayors and local entities with established disability councils, coalitions, or committees.

This conference is scheduled to take place in the spring of 2025.

2025 Parking Taskforce Council Initiative

RS 2584 - Accessible parking privileges investigation committee

The office of disability affairs is hereby authorized to establish a committee comprised of membership as it deems appropriate for the purpose of consideration of matters relative to accessible parking privileges. Such committee may:

- (1) Monitor issuance and usage of license plates and parking cards intended for use by persons with disabilities.
- (2) Review complaints regarding unauthorized use of license plates and parking cards.
- (3) Consider and evaluate evidence of abuse or unauthorized use of such plates or cards, as such evidence may be submitted to the committee by individuals, and submit such evidence or materials to the appropriate authorities and advocate for investigation of abuse.
- (4) Submit evidence or materials to the Louisiana Medical Advisory Board within the Department of Public Safety and Corrections if such evidence or materials indicate possible inappropriate or illegal certification of a person as having a mobility impairment. If, in the board's discretion, the review of such material does indicate possible inappropriate or illegal certification by a physician, the board shall submit such material along with a recommendation for appropriate disciplinary action to the Louisiana State Board of Medical Examiners.
- (5) Monitor, evaluate, and propose and advocate changes to laws, rules, and regulations relative to accessible parking privileges to the extent allowable by law.
- (6) Perform any service pursuant to its purpose authorized by the office of disability affairs.

Applications for membership will be transmitted this fall with the first meeting to take place in the spring of 2025.
