It is with great sadness the Louisiana Developmental Disabilities Council announces the passing of Council Member Lauren Womack. Lauren was an incredibly dedicated member of the Council who was appointed by then Governor John Bel Edwards on August 11, 2023. She quickly demonstrated to her fellow Council members her passion and commitment to positively impacting all Louisianans with disabilities.

Lauren was always one of the first to volunteer to serve on Council committees. She served as the Chair of the Council's 2024 Legislative Advocacy Ad Hoc Committee. She also contributed her knowledge and expertise to the Self-Determination and Community Inclusion Committee, Act 378 Subcommittee, 2025 Planning Committee, By-Laws Ad Hoc Committee and the Council's Membership Committee. Through these committees, Lauren worked to ensure the success, health and safety of people with disabilities in all aspects of community life. She was fiercely passionate about fixing the Direct Support Worker staffing crisis and ensuring people with disabilities had competitive and integrated employment opportunities.

Lauren accomplished was an professional. She advocate and received her Master's Degree in Rehabilitation Counseling from University and helped Southern numerous people with disabilities realize their career goals through her work as a Vocational Rehabilitation Counselor at Lafayette Consolidated Government. Lauren also served on boards numerous and councils including the Louisiana Rehabilitation Council, the National Employment Networks Association (NENA) and Chaired the State as a Model Employer (SAME) Task Force for the Governor's Office of Disability Affairs. She also represented the Council on the National Association of Councils on Developmental Disabilities' National Self-Advocacy (NACDD) Committee.

Lauren was very supportive of and active in the Council's advocacy network, LaCAN. She frequently followed up with her regional LaCAN Leader to ensure she was informed about upcoming advocacy opportunities and issues impacting her area. Lauren also recognized in order to create systems change, she must share her story as a person with a disability. She provided testimony at her local LaCAN Legislative Roundtable and during Louisiana's 2024 Regular Legislative Session. Her advocacy and testimony helped convince the legislature to appropriate over \$10 million to increase the night rate in I/DD waivers to match the day rate.
