Motion made by Roslyn Hymel, seconded by Mitch Iddins, for the Council's FY 2021 legislative advocacy agenda item to request a \$2.00 base pay increase for direct support professionals within all home and community-based service providers failed by a vote of 9 no's and 2 yea's. Abstentions were made by the following members: Patti Barovechio, Melissa Bayham, Michelle Guillory, Julie Foster Hagan, Jill Hano, Jennifer Katzman, Chris Rodriguez, Matthew Rovira, Temisha Sonnier.

MOTION PASSED.

Motion made by Mitch Iddins, seconded by Michael Billings for the Council's FY 2021 legislative advocacy agenda item to request a \$2.00 base pay increase for direct support professionals within all home and community-based services providers passed by vote of 10 yea's. Abstentions were made by the following members: Patti Barovechio, Kim Basile, Melissa Bayham, Michelle Guillory, Julie Foster Hagan, Jen Katzman, Chris Rodriguez, Matthew Rovira, Temisha Sonnier.

AMENDED MOTION PASSED. Motion made by Chris Rodriguez, seconded by Hyacinth McKee, for the Council's FY 2021 legislative advocacy agenda item to request a \$2.00 rate increase for all home and community-based services provided by direct service workers with no less than 70% of the increase being provided directly to the service workers passed by vote of 11 yea's and 1 no. Abstentions were made by the following members: Patti Barovechio, Melissa Bayham, Michelle Guillory, Julie Foster Hagan, Jen Katzman, Matthew Rovira, Temisha Sonnier.

The Council's FFY 2022-2026 Five-Year Plan was ratified by unanimous consent.

Education and Employment Committee

Unanimous consent was granted for the Education and Employment Committee to provide recommendations directly to the FY 2022 Planning Committee on initiatives for consideration.

Self-Determination/Community Inclusion Committee

The Self-determination and Community Inclusion Committee recommends the following be provided to the FY 2022 Planning Committee for consideration:

1. Under Objective 2.1, create a list of providers by region to be posted on the Council and Louisiana Department of Health's websites. This list should include home and community-based providers, primary care and specialist care providers, preventive health services, prevention of chronic disease services, dental, behavioral health and sexual/reproductive health services. This list would also be made available to case managers for distribution.
2. Under Objective 2.2, establish an initiative to educate first responders and direct support professionals on how to treat individuals with disabilities in an unbiased manner.
3. Under Objective 2.3, establish an initiative to address discrimination in housing for people with disabilities.

MOTION PASSED. Motion made by Roslyn Hymel, seconded by Mitch Iddins for the Self-Determination and Community Inclusion Committee recommendations be provided to the FY 2022 Planning Committee for consideration passed with no objections and 1 abstention by Jill Hano.
