In 2023, the Council made great progress towards their goals including the significant focus of the Council's work in supporting advocacy and leadership development, along with goals targeting community supports, inclusive education, and competitive integrated individual employment for individuals with intellectual and developmental disabilities (I/DD). Partners in Policymaking held the first in-person class since the COVID-19 pandemic in 2020, and the Council witnessed the return of the Louisiana Youth Leadership Forum (LAYLF) for the first time since Hurricane Katrina.

There were also key legislative wins that were impacted by Council advocacy including additional funding for the Regional Families Helping Families Resource Centers and the Postsecondary Inclusive Education Fund which funds programs for students with I/DD Louisiana postsecondary institutions. Additionally, the "Fully Included" video series wrapped up the last six videos in the series on the importance of inclusion of the disability community in aspects of everyday life. The Council should be very proud of all the great work accomplished in 2023 and look forward to LaDDC continuing to be a trailblazer in community inclusion and disability rights for all people with I/DD in Louisiana during 2024.

WHO WE ARE

The Louisiana Developmental Disabilities Council was established in 1971 as a result of the passage of the <u>Developmental Disabilities</u> <u>Assistance and Bill of Rights Act</u>. The Council is made up of twenty-eight Governor-appointed individuals from across the state who are persons with intellectual and developmental disabilities (I/DD), parents, advocates and representatives from public and private agencies. The Council members are tasked with the development and implementation of a five-year plan to address needed changes in the service delivery system for persons with I/DD.

WHAT WE DO

The Council engages in advocacy, capacity building, and systems change activities that contribute to a coordinated, person-centered and directed system of community services and supports.

OUR MISSION

The Council's mission is to increase independence, self-determination, productivity, integration, and inclusion for Louisianans with developmental disabilities by engaging in advocacy, capacity building, and systems change.

LaCAN furthers the Council's mission by advocating for policies and systems that support inclusion everywhere people learn, work, live, and play.



LaCAN provides information and support to individuals wishing to effectively advocate for systems change in the areas of home and community-based services, education, and employment.

LACAN ADVOCACY ACTIVITIES

Legislative Roundtables

Roundtables provide an opportunity to meet with legislators in your area, get current information on state Issues, increase your ability to be an effective advocate, and learn techniques for sharing your personal story to encourage positive changes.

Legislative Visits

LaCAN Leaders support their regional members in making personal visits with their legislators by providing speaking points and helping members with their personal story and message.

Yellow Shirt Days

LaCAN members show up at key committee meetings when critical decisions are being made. We find it crucial to let policymakers know the possible effects of these bills and policies on individuals with intellectual & developmental disabilities (I/DD) and their families.



Information & Action Alert

Alerts inform LaCAN members of proposed changes to policy that may affect individuals with disabilities and the services they receive as well as what specific action they can take to advocate regarding these changes.

LACAN LEGISLATIVE WINS

- An additional \$500,000 was added to the Council's state general fund for Families Helping Families Regional Resource Centers.
 - Incontinence supplies was added as a covered benefit for adults enrolled in the New Opportunities, Residential Options and Supports Waivers.
 - Open Meetings Law was amended to allow members of the public an Americans with Disabilities Act accommodation to participate in meetings electronically.
- \$1 million was appropriated to the Postsecondary Inclusive Education Fund to fund programs for students with intellectual and developmental disabilities.

PARTNERS IN POLICYMAKING



Partners in Policymaking is a national leadership training program for people with intellectual and developmental disabilities (I/DD) and parents of young children with I/DD.



It provides the most current knowledge about disability issues and develops the skills necessary for effective advocacy to influence public policy at all levels of government.

PARTNERS GRADUATES

CLASS OF 2023

The class of 2023 ended with 12 graduates of the program. The graduates were active in systems change, with 10 participants being active in advocacy and self-advocacy training events such as Legislative Roundtables, Yellow Shirt Days, Legislative Visits, and Action Alerts



ALUMNI

- 5 graduates serve on the DD Council.
- 4 graduates serve as LaCAN Leaders.
- 2 graduates serve as FHF Directors.
- 32 graduates sit on other Boards and Committees.

YOUTH LEADERSHIP FORUM

The Louisiana Youth Leadership Forum (LAYLF) is a four-day residential leadership program focused on empowering youths with disabilities while promoting an environment of disability culture and pride. This program gives delegates the skills needed to become future leaders!

100% of delegates and guest speakers and 50% of staff at LAYLF are persons with disabilities.

FIRST RESPONDER TACTICS TRAINING

Interaction Advisory Group (IAG) produced skill-building training activities for first responders and self-advocates to raise awareness and understanding of appropriate tactics for encounters with individuals with intellectual and developmental disabilities (I/DD) that promote safety and fair treatment. These activities are intended for first responder agencies to utilize information from these trainings to establish and implement policies and protocols to reduce arrests and physical escalations.



In 2022 IAG trained 156 participants. In 2023 that number increased to 502. A majority of those trained were first responders, exceeding our goal.

TRAINING ATTENDEE

"I feel the training hit on all aspects of the behavioral spectrum and other disabilities. I say this coming from my 22 years, thus far serving in law enforcement, division of corrections, and being a mother of a special needs child... LOUISIANA ALLIANCE OF POST-SECONDARY INCLUSIVE EDUCATION

Louisiana Alliance of Post-Secondary Inclusive Education (LAPIE) was formed with grant funding by the Council with the goal to increase post-secondary inclusive education opportunities for students with intellectual & developmental disabilities (I/DD).

LAPIE had 6 programs at the start of 2023, but increased to 9 programs by the end of the year.
