National Disability Employment Awareness Month (NDEAM)

The U.S. Department of Labor's Office of Disability Employment Policy (ODEP) has chosen "Advancing Access and Equity" as its theme for National Disability Employment Awareness Month in 2023. Observed each October, NDEAM celebrates the contributions of America's workers with disabilities past and present and showcases supportive, inclusive policies and practices that benefit employees and employers alike. Similarly, ODEP will use "Advancing Access and Equity: Then, Now and Next" to celebrate the passage of the Rehabilitation Act a half-century ago and its importance in prohibiting discrimination based on disability in employment by federal agencies, federal contractors and recipients of federal funds, and in the delivery of federally funded programs and activities. ODEP will use the theme to promote activities to mark passage of the act, the first federal legislation to address access and equity for people with disabilities.
