#### **July 13, September 14 – OCDD State Advisory Committee (SAC)**

Multiple updates were shared from the Regional Advisory Committees and the department.

Updates included information from the 2022 Regular Legislative Session and other needs.

Topics included:

- OCDD budget update, legislative update, federal funding received from the American Rescue Plan, an update on Act 421 Children's Medicaid Option program, and SUNS assessment updates.
- Updates on the COVID19 pandemic and continuation of the Appendix K exceptions.
- Implementation of comprehensive dental for adults on OCDD waivers and residing in ICF/DDs.
- Report on complaint and investigative processes by the Health Standards Section was also discussed.

Note many updates provided at the July meeting were also shared with the full Council during agency updates at its July quarterly meeting. Many of the September updates will also be shared at the Council's October meeting.

## September 19 – **GACDA Education Committee**

Multiple updates and discussions were had on many education issues including, but not limited to,

- Act 576 of 2022 and updates to membership of local special education advisory councils
- Department of Education efforts to codify cameras in special education classrooms into its rules. Plan to disperse funding to districts based on estimated number of eligible classrooms and funds should be available by end of September. Expenses incurred will be reported to BESE annually (in June)
- Update on LaPIE legislation and progresses made during first two meetings. Hoping to expand postsecondary inclusive education opportunities in North LA

## September 20 – **GACDA Legislative Committee**

Members discussed legislation passed in previous sessions that may need additional follow up. It was determined that additional oversight would be needed to ensure closed captioning services were offered by the legislature and continued work with the taskforce to ensure virtual participation in public meetings were accomplished. A taskforce regarding accessible voting was also created last session but has not met yet. The committee also discussed possible new legislation including incontinent supplies for adults on all Medicaid waivers and requiring generators for ICF/DDs. There was also discussion about continued efforts to get additional funding for Community Choices Waiver slots and the possibility of creating a fund for the OAAS population similar to the NOW Fund. A motion was passed to recommend GACDA send a letter to ensure funding is added to the base budget that aligns with American Rescue Plan funds so there will be continued stable funding at current rates and amounts.
