#### **Louisiana Rehabilitation Council (LRC):**

The January LRC meeting is scheduled for Thursday, January 23, 2020 at the Courtyard by Marriott (Tiger's Den), 10307 North Mall Drive, Baton Rouge, LA 70809 from 9:00am until 3:30pm. The Council is currently working on the Annual Report for the 2018-2019 year which is due December 30, 2019. There are currently four vacancies on the council.

#### **Training:**

The Houma Region has scheduled a seminar with Dr. Bergeron to provide mental health training to the Rehabilitation Counselors. The Counselors were able to submit topics to Dr. Bergeron based on current trends they are seeing. Also, Dr. Bergeron offered to explain any psychological evaluations that are complex and provide guidance or insight. New Orleans Counselors have been invited to attend this training as well.

All Regional Managers attended a video meeting to discuss American Sign Language training for staff. Each Regional Manager is meeting with their staff to determine which staff are highest priority for ASL training. We are hoping to have all interested employees registered through an online program to begin training at the beginning of next year. We are excited for this opportunity and know this will be a great benefit to our counselors and consumers.

As we continue to hire new Rehabilitation Counselors, the training department is working on scheduling the next New Counselor Academy in 2020.
