## Louisiana Rehabilitation Services (LRS) LRS Director's Quarterly Report October 2023

#### PROGRAM SERVICES

### **Pre-Employment Transition Services**

Louisiana Rehabilitation Services (LRS) provides Pre-Employment Transition Services (Pre-ETS) to students with disabilities between the ages of 16 and 21 with an active Individualized Education Plan (IEP) or who meets the definition of a student with a disability as covered under Section 504 or who is a student who has a documented disability. Pre-ETS include Job Exploration Counseling, Work-Based Learning Experiences, Counseling on Post-Secondary Opportunities, Workplace Readiness Training and Training on Self Advocacy. LRS is currently providing services to approximately **3,400** students statewide.

LRS currently has 15 active Third Party Cooperative Arrangements (TPCA) with local or state education providers to provide Pre-ETS and is continuing to pursue additional TPCA's with local and state education providers.

#### **ADMINISTRATIVE SERVICES**

### Louisiana Rehabilitation Council (LRC):

The next LRC quarterly meeting is scheduled for October 26, 2023, and will be conducted at Hampton Inn & Suites (11271 Reiger Rd., Baton Rouge, LA). Information for this meeting will be posted to the Boards and Commissions' website. Members of the LRC will also participate in an Orientation event on October 25, 2023. ### **Benefits Planning:**

Thirty-four (34) LRS consumers have been directly assisted with their SSI and SSDI benefits planning since July 1, 2023, from the LRS in-house Community Partner Work Incentives Counselor. Lighthouse for the Blind and LSU Human Development Center also continue to provide Work Incentives Planning and Assistance.

#### Statewide disABILITY Inclusion Job Fair:

In conjunction with National Disability Employment Awareness Month, the 2<sup>nd</sup> Annual Statewide Virtual Job Fair will be conducted on October 11, 2023. LRS is once again collaborating with Healthy Blue to host this event. LRS staff is coordinating both employer and applicant recruitment. Over 70 employers have registered to participate. LWC social media posts have been released to help ensure job seekers who have disabilities are aware of this event.

### **DIF (Disability Innovation Fund) Project:**

Dr. Noel Ysasi is a new Southern University (SU) faculty member and has been added to the STEMM-Up team as a Co-Investigator, filling the role that was left by Dr. Derek Ruiz when he became the Principal Investigator. As the second year of the grant comes to a close, there has been an increase in the number of referrals. As a measure to increase public awareness, both SU and LRS have intensified outreach efforts. Most recently, the Career Pathway Coordinators have been conducting outreach to high schools and colleges with a focus on STEMM programs and campus offices of disability services; while LRS began social media blasts regarding STEMM-Up on all LWC social media pages and websites. Project STEMM-Up encompasses the development of a Community Engagement Guide. Initially, SU began working with the Community Based Advisory Board to develop; however, it was decided that SU and Michigan State University (MSU) would work together to complete one Community Engagement Guide that could be used for both Michigan and Louisiana with information specified for each state as necessary. As part of the project activities, SU conducted the second of two planned trainings on Diversity, Equity, Accessibility, and Inclusion for LRS staff on Wednesday, 9/27/2023.
