PROGRAM SERVICES

Pre-Employment Transition Services

Louisiana Rehabilitation Services (LRS) provides Pre-Employment Transition Services (Pre-ETS) to students with disabilities between the ages of 16 and 21 with an active Individualized Education Plan (IEP) or who meets the definition of a student with a disability as covered under Section 504 or who is a student who has a documented disability. Pre-ETS include Job Exploration Counseling, Work-Based Learning Experiences, Counseling on Post-Secondary Opportunities, Workplace Readiness Training and Training on Self Advocacy. LRS is currently providing services to approximately **3,051** students statewide.

LRS currently has 14 active Third Party Cooperative Arrangements (TPCA) with local or state education providers to provide Pre-ETS and is continuing to pursue additional TPCA's with local and state education providers.

Louisiana Rehabilitation Council (LRC):

The LRC continues to have quarterly meetings with the next one scheduled in-person for Wednesday, August 3, 2022, at a location still to be determined. Statewide disABILITY Inclusion Job Fair:
