The speakers were Deborah Whitfield, Julie Foster Hagan (OCDD), Ashley McReynolds (The ARC), and Sue Killiam (LSU HDC). • The fifth session took place in May 2024. The National Association of Councils on Developmental Disabilities (NACDD) hosted Self-Advocacy committee meetings on May 23rd and June 20th. The DD Council shared information via email and DD Council members were encouraged to attend.

The DD Council adopted its Federal Fiscal Year (FFY) 2025 Action Plan during their April quarterly meeting, which included new initiatives. The Council sought public comment on their FFY25 Action Plan and shared a [LaDDC Newsletter](#) on April 24th encouraging stakeholders to provide feedback by June 10th.

The DD Council will be participating in Disability Pride Month in July, and asked stakeholders to share their stories throughout the month of July. The DD Council shared information on how to participate in the Disability Pride campaign including creating and sharing a short video throughout the month of June on the Council's social media platforms and sent to Council members on June 24th. FFY 2024 Cost: \$45,000</p>	<p>The Youth Leadership Forum had their 2024 camp session June 20-23 at the University of Louisiana Lafayette. There were 10 delegates in attendance. Many speakers and panelists, including Lillian Dejean, Rashad Bristo and Myron Wright had the privilege of imparting their personal experience and wisdom to the teenage delegates. Additionally there were delegates from last year who came back to assist as staff this year. FFY 2024 Cost: \$30,000</p>	<p>The Council has collaborated with People First of Louisiana to offer ten (10) statewide training opportunities (1 web-based and 9 in-person) to empower and educate individuals on voting rights for people with disabilities. Attendees will gain valuable information about: Why you should vote; The process of voting; Assistance and accommodations with voting; Rights and Responsibilities; and The meaning of Constitutional Amendments.</p> <p>As of October 2023, one (1) web-based training occurred with four (4) participants in attendance and five (5) in-person trainings with sixty (60) participants in attendance. The in-person training session included representatives from the Secretary of State’s office to provide hands-on experience with voting machines used for both early voting and election day voting.</p> <p>The training schedule will continued to be shared with all stakeholders. The training institute was held via Zoom May 7th, 9th, 14th and 16th, and Council staff attended. Sessions included: Leading for Engagement: Culturally Competent Practices to Engage People from Diverse Communities and Backgrounds, Leadership Development: Investing and Enhancing Council Member Leadership Skills and Leading through Key Leadership Transitions: Before, During, and After.</p> <p>The National Association of Councils on Developmental Disabilities (NACDD) encouraged all stakeholders to celebrate the 25th Anniversary of the Olmstead Decision on June 18th. <p>Obj. 2.1 Individuals with intellectual and developmental disabilities will have increased access to appropriate and affordable healthcare, including primary and specialist providers, preventive health services and prevention of chronic diseases, dental care, sexual/reproductive health services and behavioral health services.</p>	
<p>2.1.1 Oversee implementation of the Community and Family Support System Plan and advocate for adequate funding, the expansion of home and community based services, for waivers to provide access to services listed in the Freedom of Choice Provider Listing and consistent implementation of policy across regions, including, if necessary, changes in law and/or contracts with local governing entities (LGEs).</p>	<p>Act 4 / HB1 is the state’s Fiscal Year 2025 (FY25) budget bill that will take effect on July 1st. As it relates to the disability community, this budget, for the most part, is a standstill budget. No significant cuts or reductions were made to current disability services and programs. The \$10.1 million to increase the night rate in I/DD waivers was included in the final budget passed. With this funding, the night rate will now match the day rate. Unfortunately, the Council and LaCAN’s request for \$9.4 million to eliminate the Flexible Family Fund waitlist was not included. This program consistently has a waiting list of over 2,000 children. At the time this status update was completed, the budget was awaiting governor’s approval.</p> <p>In April, the Council was made aware that the department’s request to use American Rescue Plan Act funds on a rate methodology study was approved.</p> <p>Multiple pieces of legislation were filed throughout the 2024 Regular Session that impact home and community-based services and an individual’s ability to exercise self-determination and community inclusion. More information about these issues can be found in the LaDDC News shared on June 17, 2024 and by reviewing the Council’s bill tracking document here.</p> <p>The Centers for Medicare & Medicaid Services (CMS) released the final Ensuring Access to Medicaid Service Rule (Access Rule) on April 22nd. The Administration for Community Living (ACL) worked along with CMS in developing this rule to ensure that the experiences and priorities of people receiving Medicaid home and community-based services (HCBS) and their families, along with ACL’s disability and aging networks, were considered. The Access Rule will strengthen the HCBS that make community living possible for millions of people. It includes important new requirements related to the direct care workforce, health and safety protections, access to HCBS, quality measures, and state accountability and transparency. The Council will receive quarterly updates about the Access Rule at the Self-Determination/Community Inclusion committee from the Office for Citizens with Developmental Disabilities (OCDD).</p> <p>The Louisiana Department of Health (LDH) is actively seeking contractors to develop a rate methodology for the HCBS waivers for the Office of Aging and Adult Services (OAAS) and the Office for Citizens with</p>

	<p>Developmental Disabilities (OCDD) waiver programs. The Council will continue to receive quarterly updates from Medicaid on the progress of the rate methodology.</p> <p>Previous Quarter(s): In November, the Executive Committee removed an agenda item to advocate for increased rates and direct support worker pay until after the rate methodology was completed. This methodology will help guide advocacy efforts with regard to this ask. Council added to its 2024 Advocacy Agenda eliminating the Flexible Family Fund Waitlist (~\$9.4 million in state general fund) and increasing night rates in waivers for individuals with I/DD (\$10.1 million in state general fund). Fact sheets for each issue were created and shared at advocacy events.</p> <p>In January, LDH agreed to our request and has submitted a request to the Center for Medicare and Medicaid Services (CMS) to use those funds to complete the rate methodology. The Council decided not to include funding for this activity for FY25 due to the sensitive nature of the topic and the age of middle and high school aged individuals. It should also be noted that Youth Leadership Forum (YLF) has a topic included in their schedule that discusses healthy relationships with those participants.</p> <p>Previous Quarter(s): Staff emailed Maine DD Council and California DD Council to get information on similar activity. The last two training sessions are being scheduled in Alexandria and a city in the Central Louisiana area. Lastly, the “How to Pick a Provider” virtual training is being scheduled. The first installment of the trainings is focused on how to identify co-occurring I/DD and mental health disorders. The first session was held November 14th in Pineville, the second session was held on December 15th in Monroe and the third session was held on December 16th in Baton Rouge.</p> <p>Hustle & Grow collaborated with Pleasant Counseling & Consulting, Freedom Behavioral Health, and Finding Solace Counseling to develop topics and information for the second installment of the trainings focused on de-escalation tactics in times of behavioral health crisis. On May 22, 2024, a LaDDC News was sent about LDOE Risk-Based Monitoring Performance Audit. This audit focuses on Special Education Monitoring. Overall, the audit found that LDOE needs to improve its monitoring process to ensure all students with disabilities receive a free appropriate public education (FAPE) and all school systems follow the requirements of the federal Individuals with Disabilities Act (IDEA) and state law.</p> <p>On June 3, 2024, LaDDC sent an action alert (AA19: BESE to Discuss Special Education Monitoring Audit). In September, the Louisiana Legislative Auditor released a performance audit of the Louisiana Department of Education's (LDOE) process to address complaints related to students with disabilities.

During the October 2023 Council meeting, the Education and Employment committee expressed concerns for the new State Ombudsman the Louisiana Department of Education (LDOE) plans to hire.

The Council requested a [letter](#) be sent to the Board of Elementary and Secondary Education (BESE) before their January 2024 meeting about [Act 392 of the 2023 Legislative Session](#) expressing concerns about allowing convicted felons in the classrooms with students, especially students with disabilities. In February, Council Chair, Christi Gonzales, and Council Staff attended a Zoom meeting with LDOE to discuss the concerns over Act 392 in response to [the letter](#) the council sent to BESE.

An [Action Alert](#) was sent on January 10th informing advocates that Governor Landry, by [Executive Order](#), vetoed the Board of Elementary and Secondary Education's (BESE) new policy establishing an appeals process for qualifying high school seniors who do not meet the state's LEAP test scoring requirement for graduation.

An [Action Alert](#) was sent on March 18th about the legislature making Governor Landry's veto of BESE's new policy establishing an appeals process for qualifying high school seniors who do not meet the state's EOC/LEAP test scoring requirement for graduation a permanent decision with House Bill 8 ([HB8](#)).

An [Action Alert](#) was sent on February 26th due to the unexpected dismissal of the entire membership of the Special Education Advisory Panel (SEAP). BESE voted to allow for SEAP to meet for the March quarterly meeting with the current members, and current members were encouraged to reapply for SEAP.
