# **Review of Reports**

The committee reviewed the committee recommendations. These recommendations came from the standing committees of the council.

They also reviewed the concepts, which are big-picture ideas about how to make things better for people with developmental disabilities and their families. Concepts address change of public systems and programs, advocacy and self-advocacy development, and/or the capacity building of community supports and services.

Last, they looked at the public input report, which included ideas from the public forums, LaCAN, and a survey.

# **Initial Development of Goals**

After looking at all the information, the committee talked about which areas of emphasis were most important to include in the five-year plan. Then, they started writing the main goals. The committee drafted three goals:

- Self- Advocacy,
- · Health and Community Supports, and
- Education & Early Intervention and Employment.
